

From the sanctioned and working strength of Tax Assistants in the Kolkata CGST & CX Zone, it is observed that there are 5 negative vacancies (-5) in the category of SC. Also, there is no vacancy in the UR, ST & OBC categories. Total DR vacancies in the grade of Tax Assistant being 12, after adjusting the negative vacancies in the SC category, the total vacancies of 7 have been reported under the EWS category.




