I do solemnly express my sincerest regards & thanks here again for the constant efforts your esteemed office has been making towards providing solicited information to common citizens in the true spirit of the RTI Act.

It is now respectfully submitted that, it is learnt from industry sources & RTI replies already received from the Department that several SCNs have been issued by DGGSTI (earlier DGCEI) from various zonal offices proposing demand of Service Tax treating compensation amount (which was paid by Coal Ministry to prior allottees for de-allocation of coal mines under Supreme Court's order) as value of taxable supply under earlier Service Tax law & regulations ! It is learnt from industry sources further that one such SCN has been adjudicated at Kolkata North Comm'te in recent past.



As known to the esteemed Department, It is a fact of general legal interest in the trade that the Department (to be specific-erstwhile DGCEI of various Zonal & Regional units) suddenly entertained a view that the compensation amount paid by Coal Ministry to prior allottees against cancellation of their prior allotment & dislodging their ownership of coal mines under Hon'ble Supreme Court's Order dated 25.8.2014, was subject to levy of 'service tax' as 'declared service' in terms of Sec. 66E(a) of the Finance Act.

On the very above issue, Appeal No. ST/76001/2019 Dt. 18.4.2019 involving jurisdiction of Kolkata North CGST & Cx Comm'te (Mineral Development & Trading Corpn. Ltd.) is pending decision before Hon'ble CESTAT, Kolkata.
