DPC Unit under this Cadre Controlling Commissionerate is concerned, the desired reply as sought by the RTI applicant vide his RTI application dated 02.11.2020 is as under-

Point-wise Reply as on date -:

Shri Asish Bala (DOB - 01.04.1967) has already been promoted to grade of Superintendent on Ad-hoc basis vide Estt. Order No. 52/2020 dated 15.09.2020 in the Annual DPC for the year 2020.

It is worthwhile to mention that the last Seniority List of Inspector grade of this zone which was published on 30.11.2015 (as on 01.04.2015) by the then Central Excise Kolkata -II Commissionerate (now Howrah Commissionerate) is under sub-judice at this juncture before the Court of Law for further Promotion to the grade of Superintendent. CBIC (Board) has also instructed vide letter dated 31.07.2020 "to keep seniority issues in the grade of Inspector in abeyance till clarification is received from DOP&T or until further directions in this regard".

It is also pertinent to mention that Howrah CGST & CX. Commissionerate is the Cadre Controlling Commissionerate in respect of Inspector grade of this Kolkata Zone.

In the Annual DPC for the period 2020 held on 15.09.2020, all the promotions from the grade of Inspector to the grade of Superintendent have been given only on Ad-hoc basis due to non-finalisation of Seniority list issue in respect of Inspector grade of this zone (Inspector is the feeder cadre/post for promotion to the grade of Superintendent).

After finalisation of seniority list in the grade of Inspector in terms of DoPT/CBIC/Legal Instructions, through Review DPC this promotion order may be revised accordingly (the same line was clearly mentioned in the Estt. Order No. 52/2020 dated 15.09.2020).
