Requesting you to direct the concerned to provide the requested details so as to understand that how much has the influx of China Made Truck Tyre hurt Indian Tyre Companies in the state of West Bengal over the mentioned period.

This is to bring to your notice that since June 2021, there has absolutely massive influx of China made truck tyres which are being imported in the state of West Bengal as they are way cheaper than Indian Products - For eg - Any India Made Truck Radial tyres by an Indian Company costs around 20,000-23000, where as these Chinese tyres are selling at 16,000, resulting into loss of Indian Business and Jobs too.

Also, there are concrete reports of TAX Evasion by these importers of Chinese Tyres which should be looked into by the Revenue Intelligence department.
