Sub: My Application under Right to Information Act dated 15.9.2018 to the Central Public Information Officer, CENTRAL BOARD OF EXCISE & CUSTOMS, Department of Revenue, Ministry of Finance, New Delhi.

Ref: Reply dated 24.10.2018 received not satisfactory and appeal sent to Appellate Authority dated 29.10.2018 and information being withheld without giving the full information sought for by order dated 14.12.2018.

I state that I belong to the Scheduled Caste Community and I am now 66 years of age.

I sent application dated 15.9.2018 to the CPIO of CBEC, Department of Revenue, Ministry of Finance, seeking the following information under the provisions of the Right to Information Act to :

1. Kindly furnish the details of the names of persons with details of their date of birth and date of joining/promotion as Inspector of Central Excise promoted from 1.1.1997 till 31.12.2014 from the cadre of Superintendent of Central Excise, Group (B) to the post of Assistant Commissioner.
2. Kindly furnish the details of the names of persons who belong to Schedule Caste category in the list of promotees from the cadre of Superintendent of Central Excise, Group (B) to the post of Assistant Commissioner with details of their date of birth and date of joining/promotion as Inspector of Central Excise.
3. Kindly inform whether reservation for Scheduled Caste category was made and promotions effected from 1.1.1997 to 31.12.2014 in the list of promotees from the cadre of Superintendent of Central Excise, Group (B) to the post of Assistant Commissioner and if so what is the percentage of such reservation and also giving total number of vacancies of the promotion posts category wise (OC, BC, SC, ST, PH etc).

However, I did not get the complete information as available and the replies were evasive and without material particulars. I am enclosing copies of my application as well as the reply sent by the Department for your kind perusal. I am suffering from Cataract in my eyes and taking care of my very old father who is aged above 90 years and undergoing treatment and I am having difficulty in walking and hence could not appeal to you in time and cannot leave Chennai to travel to New Delhi for verifying the records relating to the information sought by me and hence I pray that the complete information may be furnished to me with the copies of the documents where such information is kept by the Department and I am willing to bear the cost of providing such copies of documents. As it relates to my denial of promotion from Superintendant, Central Excise to Assistant Commissioner, Central Excise and fixing of lower pay scale and consequent revision of my pay and pension and considerable time has lapsed, I request that the full information may be furnished at an early date.

However, I received a reply dated 24.10.2018 which did not give the complete information as available and the replies were evasive and without material particulars and I therefore sent a First Appeal dated 29.10.2018 to the Appellate Authority and Deputy Secretary. The said Appellate Authority by order dated 14.12.2018 held that as the records are voluminous I am allowed inspection of the available records at New Delhi after prior appointment on any mutually convenient date. Aggrieved by the said order dated 14.12.2018 I have sent a Second Appeal dated 1.2.2019 to the Chief Information Commissioner, Central Information Commission, New Delhi expressing my inability to travel to New Delhi due to my ill health and also taking care of my 90 year old father and my second appeal is still pending.

While so, I am surprised to receive a letter in F. No.8/B/03/HRD (HRN)/2014/Pt.1/6223 dated 6.6.2019 from the second of you informing me that there is no action required from your end and if I am aggrieved I may file an appeal before the first of you within 30 days of receipt of the said letter. I received your above letter only on 11.6.2019 and as my Appeal before the Central Information Commission is pending challenging the very same order by which incomplete information was given, I feel it is not required on my part to file any Appeal to the second of you.
