Please refer to your letter issued under C.No.V(30)08/RTI/HQ/CGST&CX/Kol North/2022/23477 dated 17.01.2022 on the above mentioned subject.

In this regard, this is to inform you that the information sought by the applicant is relating to a sub judice matter pending final consideration and decision by the Hon'ble High Court at Calcutta and certain orders have been passed by the Calcutta High Court in these matters. The company, namely Mangalam Organics Limited, has subjected itself within the jurisdiction of the Calcutta High Court by challenging the order of the concerned authority. Any information relating to the manner of conducting of the case/litigation on behalf of the department, stand of the department, internal communications between the department and the conducting Advocate are privileged communications with the conducting advocate in a subjudice matter and hence cannot be disclosed. The informant is also asking about 3rd party information relating to a company, who has filed a litigation before the High Court at Calcutta and the department cannot furnish any information relating to a person seeking information about the litigation instituted by a company since the information relating to the conducting of the litigation is in the records of the Calcutta High Court and a third party information. Due to reasons as mentioned aforesaid, no information can be furnished to the applicant.


