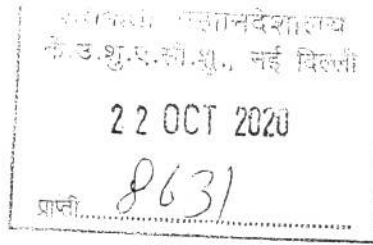

As you are aware that rule 14(24) of CCS(CCA) Rules, 1965 has been inserted vide Govt of India notification dated 02.06.2017 laying down a statutory period of 6 months for the completion of departmental inquiries against Govt servants, herein referred to as the 'statutory rule'. The same was circulated vide CBIC circular dated 01.08.2017 and your chairman also mentioned the same in his DO letter dated 30.08.2017.

The below listed information is solicited under the RTI act section 6 "Request for obtaining information":
