**Information Sought :** I have joined to this department as Inspector of Central excise on 16.09.1988 and 1st ACP was granted on 16.09.2000. NFG was granted on 23.09.2002. My 3rd MACP was due on 23.09.2016. But till date the same was not granted by the Cadre Controlling Authority, kolkata North CGST & CX Commissionerate. No action was initiated either by the Kolkata North CGST & CX Commissionerate or by the Haldia CGST & CX Commissionerate for so long. I was last posted as Superintendent in Junglepur Division under Haldia Commissionerate. Ultimately Haldia Commissionerate sent the IC/VC and APAR/ACR grading on 30.06.2021. Last MACP order was issued by the Kolkata North CGST & CX Commissionerate on 10.11.2021, but my name was not included in the list. I want to know the status of my MACP case. What is the reason for non issuance of my name against the said order. My superannuation is due on 31.05.2022. Kindly intimate me the present status of my case.
