CPIO, Dept. of Legal Affairs, had held that 'the RTI Act does not cast on public authority any obligation to answer queries in which the petitioner attempts to elicit answer to his queries with prefixes as why, what when and whether. The petitioner's right extends only to seeking information as defined in section 2(f) either by pointing the file documents, paper or record etc., or by mentioning the type of information as may be available with the specified public authority.'

If you are aggrieved or dissatisfied with the above information, you may prefer an appeal within 30 (thirty) days of receipt of the information before the 1st Appellate Authority namely Sri P. K. Bohra, Additional Commissioner & FAA, CGST & CX, Kolkata-North Commissionerate, O/o The Principal Commissioner of CGST & CX, 2nd Floor, Kendriya Utpad Shulk Bhawan, 180, Shantipally, Rajdanga Main Road, Kolkata-700107.
