It has been ordered that the suspension against Shri Rajeev Ranjan, Insp (under suspension since 12.02.2021) has been revoked with immediate effect (i.e. from 10.05.2021) and Shri. Ranjan is entitled to receive regular pay & allowance as per rule.

The period of suspension from 12.02.2021 to 09.05.2021 in respect of Shri. Ranjan is yet to be decided by the Disciplinary Authority.
