Kolkata North CGST & Central Excise Commissionerate as the Cadre Controlling Commissionerate will conduct the Review Departmental Promotion Committee Meeting for notional promotion to the Grade of Tax Assistant, in respect of the Combined Commissionerates of CGST & Central Excise, Kolkata Zone (CGST & Central Excise Kolkata North/Kolkata South/Howrah/Haldia/Bolpur/Siliguri/Audit-I/Audit-II/Audit Durgapur/ Appeal-I/ Appeal-II/ Appeal Siliguri And Commissionerate of Customs(P), West Bengal. Shri R.K.Misra, Additional Commissioner of Kolkata Appeal-I Commissionerate, Kolkata, is designated as Chairman of the Review Departmental Promotion Committee.

The DPC for promotion to the grade of Tax Assistant for the year 2016-17 was held on 21.04.16, wherein 16 officers were promoted to the grade of Tax Assistant w.e.f. 22.04.16 (i.e. date of issuance of promotion order to the grade of Tax Assistant) vide E.O.35/2016 dated 22.04.16 (Annexure-I).

The Chief Commissioner, Central Excise, Kolkata has approved to Review the above mentioned DPC for vacancy year 2015-16 in the grade of TA vide NSP-31-34 of File No II(3)6-ET/CON/A-3/Kol-I/2011(ANNEXURE-II)

In view of above, this Review DPC may review the DPC held on 22.04.16 and grant notional promotion to the eligible candidates w.e.f. their date of eligibility, i.e. 01.04.2015 and 01.04.2016 as vacancies were already very much available on that dates. It is informed that out of the 16 officers promoted vide EO35/2016 dated 22.04.16, there are 14 officers have satisfied and fulfill all the criterias for promotion to the grade of TA for the vacancy year 2015-16, i.e. 01.04.2015 according to the RR of Tax Assistant vide G.S.R. 12 (E) dated 10.01.2014 and Amendment vide GSR 720(E) dated 15.09.2015. (**Annexure-III**) The officers at Sl. No. 3 & 12 of the consideration zone(i.e. Shri Susanta Roychowdhury and Shri Gopal Chandra Sardar) have passed the Senior Secondary Exam on April-May 2015 and 18.02.16 respectively(**Annexure-IV**).Therefore these 02 officers are not eligible for promotion to the grade of TA as on 01.04.15. However both the officers have passed the Senior Secondary exam before 01.04.16. Therefore they become eligible for promotion to the grade of TA for the vacancy year 2016-17, i.e. on 01.04.16 as per RR of TA.

Further one more Annual DPC was held on 18.05.17 for promotion to the grade of TA for the vacancy year 2017-18, where in 10 Officers were promoted to the grade of Tax Assistant vide EO 60/2017 dated 19.05.17(**Annexure-V**)

All these 10 officers were eligible from 01.04.17, therefore this Review DPC may grant notional promotion to these 10 officers w.e.f. their date of eligibility (i.e. on 01.04.17)

Further it was informed to the DPC that, as the 14 officers of Sl.No. 1-2, 4-11 & 13-16 of the consideration zone were promoted by the previous DPC in the vacancy year 2016-17 and may be reviewed by this DPC from their date of eligibility (i.e. vacancy year 2015-16), therefore VC/IC, ACR/APAR gradings and Dossiers have been called for only these 14 officers for the vacancy year 2015-16. For rest of the officers the date of eligibility remains the same financial year (i.e. 2016-17 i.e. 02 officers & 2017-18 i.e. 10 officers), therefore VC/IC is not required for these 12 officers.

FINDINGS OF THE D.P.C.

In view of above, the present Review DPC may consider the candidates who were in the select panel of the Review DPC held on 21.04.16 & 18.05.17 and grant notional promotion to the officers w.e.f. 01.04.15, 01.04.16 & 01.04.17. The officers who will be considered are to be graded by the Review DPC as 'FIT' or 'UNFIT' with reference to the ACR/APAR Synopsis and those found 'FIT' are to be included in the panel as per the seniority decided by the ensuing DPC.
