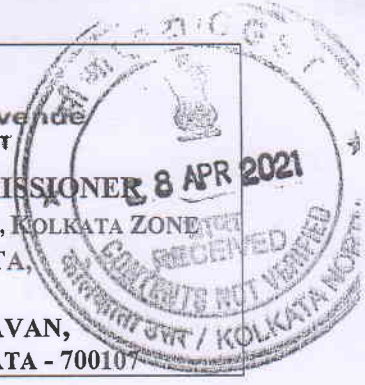

MSME Certificate is a supporting document apart from proof of ownership document of principal place of business address.
