2) The above 4 districts 4 Cable<sup>T.V.</sup> operators are paying to your  
dept. Per month several lacs of Rupees. as G.S.T. Actual  
amount Per month paid by the cable<sup>T.V.</sup> operators. and total  
Cable line Per Cable<sup>T.V.</sup> operators. informations be sent home.

3) I think that cable operators suppressed the G.S.T.  
payment to your dept. as the Security Agency suppressed  
the payment of Service Tax to your Dept. After getting the
