Sir/ Madam,

Sub: Scheme for funding of Annual Health Checkup for Group 'B' and Group 'C' officials of age 40 years and above from the Customs & Central Excise Welfare Fund-reg.

Kind attention is invited to the D.O. letter of even number issued by DG. HRD on 17.01.2020 on the above mentioned subject.

2. In terms of the implementation of the Scheme, the Zonal Pr. Chief Commissioners/ Pr. Directors General/ Chief Commissioners/Directors General were required to enter into Memorandum of Agreement (MoA) with reputed Hospitals/ Diagnostic Centers on the lines of MoAs entered by Ministry of Health & Family Welfare to empanel them for conducting the requisite tests of eligible departmental officials of Group 'B' and Group 'C' subject to the ceiling rates latest by 31st March, 2020, so that the Scheme may be implemented w.e.f. 1st April, 2020.

3. However, understandably, due to the outbreak of COVID-19, the important pre-requisite of entering into Memorandum of Agreement (MoA) with reputed Hospitals/ Diagnostic Centers on the lines of MoAs entered by Ministry of Health & Family Welfare for implementation of the Scheme, could not be completed by any Zone.

4. Accordingly the time-lines as specified in the aforementioned D.O. letter have been revised as under for the year 2020-21:
