1. The Directorate General of Goods & Service Tax Intelligence (DGGI), Bhubaneswar Zonal Unit and Rourkela Regional Unit are in the process of drawing up a panel of willing and suitable officers for filling up the existing vacancy in the grade of Senior Intelligence Officer and Intelligence Officer on loan basis.


