

Subject: Posting of **Superintendents and Inspectors on loan basis** in DGPM, New Delhi- reg.

Kind reference is invited to the Board's letter dated issued under F.No.11019/5/2017-Ad. IV dated 16.06.2017 wherein 12 post of Superintendents and 6 posts of Inspectors have been allocated to DGPM, Delhi on loan basis and the working staff strength against such loan basis posts is to be made available by the respective CCA i.e. CCO CGST Delhi Zone.

2. Further, the DGPM, Delhi has been entrusted with the tasks by the Board such as Saadhit, Aakalan, Cadre Control Authority for all 18 Directorates of the CBIC, New theme-based Inspection Model of OSPR, Nodal Office for Implementation of eOffice and Gov Mail's DA Admin role etc. Consequent upon the cadre restructuring, the work assigned to DGPM has now increased manifolds.

3. In this context it is to inform that currently 3 Superintendents and 1 inspector are working on loan basis in DGPM, Delhi and a total of 9 posts of Superintendents and 5 posts of Inspectors are lying vacant on loan basis as per board letter dated 16.06.2017 and the shortage is affecting adversely day to day working of DGPM.

4. In view of the above, it is requested that 9 Superintendents and 5 Inspectors may kindly be posted to this office immediately on urgent basis for the smooth functioning of DGPM.
