Subject:-Appointment of Superintendent/(AAD) on deputation basis in the Directorate of Logistics, Customs & Indirect Taxes, New Delhi–reg.

Two posts of Superintendent/(AAD) in the pre-revised pay scale of Rs.9300-34800 + 4800/5400 Grade pay & Level 8/9 (as per 7<sup>th</sup> CPC) is likely fall vacant in the Directorate of Logistics, Customs & Indirect Taxes, New Delhi. All Group 'B' Gazetted officers in the analogous Pay Scale working in the Commissionerate/Directorate/Custom House under Central Board of Indirect Taxes & Customs are eligible for appointment on deputation to this post. The period of deputation is initially three years and can be extended by one year at the discretion of the Appointing Authority and for a further period of one year on mutually agreed basis.

- 2. Officers who apply for the said post will not be allowed to withdraw their candidature subsequently. However as and when a situation arises a premature reversion to his parent Commissionerate/Directorate may be given to the officer.
- 3. The age of the officer should not exceed 56 years as on closing date of this circular.
- 4. It is requested that names of suitable and willing officers along with their APARs grading for last five (5) years, Vigilance Clearance and History of Posting as per Format-'A' (copy enclosed) may be forwarded to this office latest by 10.03.2020 along with "No Objection Certificate" from the concerned Commissionerate/Directorate.
