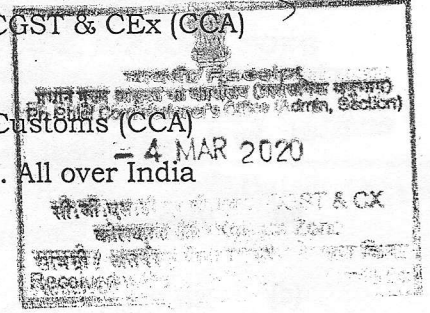

1. The Directorate General of Goods & Service Tax Intelligence (DGGI), Bhuvaneshwar Zonal Unit and Rourkela Regional Unit are in the process of drawing up a panel of willing and suitable officers for filling up the vacancy in the grade of Senior Intelligence Officer (two post at Bhuvaneshwar Zonal Unit) and Intelligence Officer (one post at Bhuvaneshwar Zonal Unit and one post at Rourkela Regional Unit) on deputation basis.
2. It is proposed to fill up these vacancies by appointing suitable officers from the grades of Superintendent of Central Tax & customs and Inspector of Central Tax & Customs, respectively.
3. Normally, the deputation is for a period of five years for the post of Senior Intelligence officer and Intelligence Officer, which is extendable by another two years, subject to the willingness of the officer, his/her performance, concurrence of his/her parent Commissionerate and approval of the Competent Authority.



4. It is requested that this circular may be brought to the notice of all officers in the formations under your jurisdiction and the application of the willing officers may please be forwarded to this office.

While forwarding the name of the willing officers, the following information in respect of them may be furnished for evaluation by the Directorate:

- (a) Complete Bio-data and Willingness letter of the officer along with history of previous postings.
- (b) ACR/APARs grading for the last (5) five years duly verified and attested by the additional/Joint Commissioner (P&V)
- (c) Vigilance Clearance Certificate; and
- (d) No Objection Certificate from the Competent Authority to relieve the officer in the event of his/her selection

5. It may be brought to the notice of the officers that once they are selected, they will not be allowed to withdraw their option and they are expected to serve in DGGI, Bhubaneswar Zonal Unit till the expiry of their tenure of 5 years.

6. In Case, while working in this Directorate, if the conduct and work of the officers are not found satisfactory, the officers shall be reverted to their parent Commissionerate prematurely without assigning any reasons.

7. The above information / details may please be arranged to be furnished to the Directorate at the earliest preferable by 31.03.2020.
