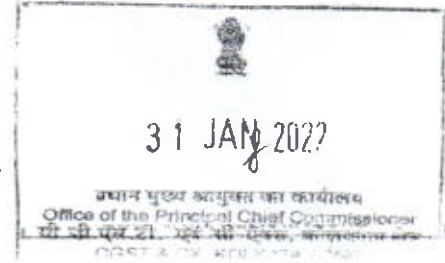

Sub: Preparation of panel for posting on deputation basis in the grade of Superintendent in the Pay Level - 8 of Rs.47,600 - Rs.1,51,100 as per the 7<sup>th</sup> CPC (Pre-revised Pay Band - II of Rs.9300 - Rs.34800 + Grade Pay of Rs.4800 of the 6<sup>th</sup> CPC) at zonal offices of O/o Chief Commissioner (AR), CESTAT, New Delhi - reg.

The O/o Chief Commissioner (AR), CESTAT, New Delhi is in the process of drawing a panel of willing and suitable officers in the grade of Superintendents for posting on deputation basis at its zonal offices. It is proposed to fill up total 06 (Six) vacant posts, 01 (One) each at zonal office located at Mumbai, Kolkata, Chennai, Hyderabad, Allahabad and Ahmedabad. The officers who have been granted financial upgradation under MACP Scheme, are also eligible to apply.

2. The terms and conditions for deputation are as under:

- Normally the posting on deputation is for a period of three years which may further be extended upto 5 years, subject to willingness of the officer, his/her performance, concurrence of his/her parent commissionerate and approval of the Competent Authority.

3. It is requested that this circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers be forwarded to this office. The following information, while forwarding the names of the willing officers, may be furnished for evaluation by this office:

- i. Complete bio-data and willingness letter of the officer along with history of postings.
- ii. No objection Certificate from the Competent Authority to relieve the officer in the event of his/her selection.
- iii. Duly attested APAR gradings for the last five years of the officer.
- iv. Vigilance Clearance/Integrity Certificate in respect of the officer.

4. It may also be noted here that the option for deputation to O/o CC (AR), CESTAT, once exercised, cannot be withdrawn under any circumstance.

5. The last date for receipt of candidature is 28.02.2022.
