

Subject: Vacancy Circular – Panel for appointment of Senior Intelligence Officers (SIO) and Intelligence Officers (IO) on local transfer/ loan basis at DGGI, Chandigarh Zonal Unit and its Regional Units - DGGI, Shimla Regional Unit and DGGI, Jammu Regional Unit – reg.

The Chandigarh Zonal Unit is in the process of drawing a panel of willing and suitable candidates for being posted as Senior Intelligence Officers (SIO) and Intelligence Officers (IO) on local transfer/ loan basis at the Chandigarh Zonal Unit office and at its Regional Units located at Shimla and Jammu, on local transfer/ loan basis.

- 2. In the case of an officer selected and appointed, the initial appointment would be for a period of 2 years. Any further extension may be considered with the approval of the Cadre Controlling Authority. The pay & allowances would be drawn from the parent Commissionerate and the officer would not be entitled to any Special allowance/ Deputation allowance, etc. Residential accommodation is not offered by this Directorate.
- 3. It is requested that the vacancy circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers be kindly forwarded to this Unit. While forwarding the names of the willing officers, the following information may also be sent for evaluation by this Directorate: -
- a) Complete bio-data and willingness of the officers along with history of posting;
- ACR/APAR grading for the last five (5) years fully verified and attested by the Additional/ Joint Commissioner;
- vigilance Clearance.
- d) NOC from the office of the Chief Commissioner to relieve the officer in the event of his/her selection
