



2. The officers selected for posting on deputation basis would initially be appointed for a period of three years which may be extended for two more years. Similarly, the officers selected for posting on loan basis would initially be appointed for a period of two years, which may be extended for one more year. Such extension of period of posting on deputation/ loan basis would be subject to his/ her performance, concurrence of his/ her parent Commissionerate and approval of the Competent Authority.

3. It may also be brought to the knowledge of the willing officers that in the event of selection, they will not be allowed to withdraw their name.
