

Kind attention is invited towards the Board's Circular issued vide F.No. A-11019/102/91-Ad.IV dated 21.10.1993 and Board's Circular issued under F.No. A-11019/22/2007-AdIV dated 22.12.2008. In term of the Airpool Policy framed vide aforesaid Board's Circular, 25% of the sanctioned strength in the grade of Air Customs Officer at Anna International Airport are to be filled from other CGST & Central Excise Commissionerate.


