

CIRCULAR

As per Rule 3 (c) of CCS (Conduct) Rules, 1964, any Government Service indulging in any sexual harassment to women in workplace is subjected to disciplinary action. Therefore, every officer-incharge of a workplace must take appropriate steps to prevent sexual harassment to any woman at such workplace.

Consequent upon the transfer of existing members of the Committee constituted vide Circular dated 10.08.2022, a new "Internal Committee" is hereby constituted in CGST & CX, HQ, Siliguri Commissionerate for dealing with complaints of sexual harassment of working women at workplace.
